Number of the existing sections should not exceed the number of the class room of proper size in the school.

- 9. That the school/society shall obtain land from the DDA for the unaided school and shall shift to classes to the new site with the permission of DE.
- 10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
- 11. That the service contract between the management and the employees shall be executed immediately.
- 13. That the arrangement of good citalking water shalls be made available to all the students as well as the beachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
